One of the hardest things I've done in my life was to go to my first AA meeting. It was difficult because I thought AA was simply a collection of losers, whiners and weak-willed nit wits who didn't have the will power to handle their booze. I also thought their meetings would consist of complaining about the evils of alcohol and of those who drank it. It didn't matter that I had no real or fact based knowledge of AA, I just knew that was the way it was.

How wrong I was! My first meeting consisted of a group of men and women of whom many shared about their struggles with alcoholism and how they recovered from it. I found this to be both odd but appealing. In fact there was enough attraction for me to return to several more AA meetings.

Along with myself were a few other newcomers who kept coming back. As the weeks went by we were joined by a few more newcomers of whom some were court ordered and others were not. Whether there voluntarily or not I heard many share with energy and passion how grateful they were to be sober. I have never doubted their sincerity when they uttered those statements.

I could see Step One working in these individuals. I could see the relief they were experiencing from being relieved of untreated alcoholism. This was the miracle of Alcoholics Anonymous and a Higher Power at work. The miracle of AA had happened!

But within a few weeks later I would no longer see most of these individuals in meetings. I was to learn that many of them relapsed and were no longer sober. What had happened to them? Why weren't they still sober?

Sobriety for most including myself was difficult at the beginning. But it occurred because of Step One and the grace of a loving Higher Power who granted us those miraculous days of sobriety. Let us remember not to leave sobriety after the miracle happens, for many who do so never return.
